

CONDITIONS OF ENTRY

Your entry into either The Guzzler 100km, the Glass Half Full 50km, the Big Sipper 21km or the Dry Run 10km (the "Event") will confirm your full understanding and acceptance of these Conditions of Entry ("Conditions"). Failure to adhere to any of the Conditions may result in immediate disqualification without refund.

- 1. You are not required to demonstrate any previous experience with trail and/or ultramarathon running in order to enter the Event however it is expected that all entrants into the 100km event will have completed at least one hilly, trail ultramarathon of 50km or longer before event day.
- 2. It is your responsibility to ensure that, on race day, you are sufficiently fit and healthy to complete the Event within the official cut-off times.
- 3. The Organisers reserve the right to change the official cut-off times at any stage prior to or during the event in the interest of participant safety or for any other reason.
- 4. You accept that if you do not make the designated cut off times at the various Checkpoints along the course, that you have no recourse for a refund.
- 5. You accept that no refund will be paid to any entrant who fails to participate or fails to complete the course for any reason.
- 6. You must be at least 18 years of age on race day to participate in the 100km & 50km Events, at least 16 years of age to compete in the 21km Event and at least 12 years of age to compete in the 10km Event. ALL RUNNERS UNDER 14 years of age on the day of the event MUST BE DIRECTLY SUPERVISED for the duration of the run that is, a parent or guardian must run with the child for the entire distance, and they too must be entered in the same event. All runners under 18 must have parent or guardian consent.
- 7. You understand that the course is technical, remote and physically demanding and that emergency medical aid may be slow to reach you. This constitutes a high risk of serious injury, or possibly death, if an emergency situation occurs while on course.
- **8.** Both before starting and during the Event, you must monitor your own health and well-being and withdraw if you are no longer fit enough to continue safely.
- **9.** You are responsible for the behaviour of your support crew and supporters. It is your responsibility to ensure they fully read and understand any available supporter information and that they do not, knowingly or otherwise, break any rules, breach the Code of Conduct or bring the Event or the Organisers into disrepute.
- **10.** Before registering, you will be required to read and agree to a Release Waiver. A copy of this waiver can be viewed on the Event website.

Prior to the start of the event, all participants will be expected to fully read and understand all available and supplied Participant Information including the Code of Conduct & Race Rules. Failure to abide by the Code of Conduct may result in disqualification from the Event and potentially from future Events. Ignorance of the rules and responsibilities laid out in the Rules, Code of Conduct, the Conditions of Entry and the Participant Waiver will not be accepted as a defence.

Insurance

The organiser of the Event, Kinevora Pty Ltd T/A Those Guys Events, has public liability insurance cover. This does not include personal accident insurance for competitors. We recommend that you arrange your own personal accident insurance, ambulance cover and income protection insurance before participating in the Event to cover any unforeseen personal costs you may incur due to ambulance trips, medical expenses or time off work due to injuries sustained whilst participating in the Event.

Refunds & Transfers

In the unfortunate instance that you can no longer participate in the event, refunds or transfers may be possible, in line with the policies that are detailed on our website.

- 1. You agree to and accept the Event refund policy that is in place at the time of your entry. We reserve the right to change this policy at any given time and the updated policy will then apply to future registrations.
- 2. Where concessions are removed, you'll still be eligible to apply the policy conditions as at the time of your entry, unless you re-enter or accept the new conditions. At our discretion, we may choose to extend further concessions to your entry, if they did not apply at the time of registration but are later added.

Please note, the Organisers reserve the right to re-route, reschedule or cancel the Event at any time, if it is deemed unsafe for any reason, or at the direction of the land managers or any other relevant authority. If the event is cancelled, changed or rescheduled, the Refund policy on our website will apply to your entry costs. No responsibility is assumed or taken by the organisers for lost travel or accommodation expenses, or for part or full loss of entry fees paid.

You may wish to take out extended refund protection through Booking Protect at the time of entry. This service is provided through a third party provider and is not administered by us. If you would like to choose this additional cover please thoroughly read and understand the policy details before entering into an agreement. While it will provide additional refund options, it won't cover all situations.
